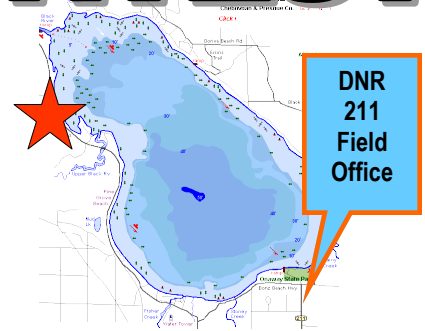

Fishing Contest Rules

Contest Date: Saturday, February 1, 2020

Registration closes Friday, Jan 31 at 7pm

\$10 Registration

80% Payback Cash and Prizes

ENTRY FEE to register is \$10.00 per angler.

Anglers may register at DNR 211 Field Office in Onaway on Friday, January 31 from 2pm-6pm, at the Shivaree tent before 7pm, or at Onaway Outfitters & Twin Lakes Grocery.

REGISTRATION closes Friday, January 31 at 7m.

The fishing contest is Saturday, Feb 1 from 6am to 6:00pm.

All fish must be legally harvested from Black Lake.

All fish must be registered at the Shivaree tent before 6pm on Saturday, Feb 1.

All fish must be weighed and measured. Three (3) lines max/per angler.

Winning fish will be determined by weight. Ties will be determined by length.

All contestants must be legal fishermen-women and comply with Michigan laws.

Prizes will be awarded for the heaviest PERCH, WALLEYE, PIKE, MUSKIE, & STURGEON*

The heaviest registered sturgeon entered into the contest will be awarded after sturgeon season is closed.

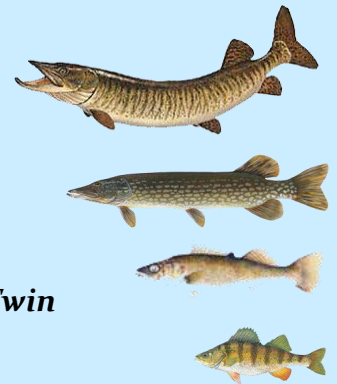
Sturgeon Season opens Saturday, Feb 1, 2020.

Fishing hours are 8am to 2pm each day of the season.

Sturgeon Season will either end at 2 p.m. on Wednesday, Feb. 5, or when 6 sturgeon are harvested, whichever comes first.

Awards take place at the SHIVAREE TENT approximately 7:00pm Saturday, Feb 1.

Judges' decisions will be final.

ACKNOWLEDGEMENT AND ASSUMPTION OF RISK
